

REGULAR SESSION, COMMON COUNCIL, OCTOBER 16, 2013

Be it Remembered that the Common Council of the City of Plymouth, Indiana, met in regular session on October 16, 2013. The meeting was held in the Council Chambers of the City Building, 124 N. Michigan Street, Plymouth, Indiana. The meeting was called to order at 7:00 p.m.

Mayor Senter led the Pledge of Allegiance and Councilman Delp offered prayer.

Senter presided for Council Members Delp, Culp, Ecker and Smith. Clerk-Treasurer Hutchings, City Engineer Gaul and City Attorney Surrisi were also present. Councilman Grobe was absent.

Councilmen Delp and Culp moved and seconded to approve the minutes of the last regular meeting on September 24, 2013 and to dispense with reading them since they have been reviewed and found to be correct. The motion carried.

Mayor Senter asked that the members table their appointment to the redevelopment commission.

Councilmen Culp and Delp moved and seconded to table the matter. The motion carried.

Senter announced that on Wednesday, October 23<sup>rd</sup> there will be a Town Hall meeting at 6:30 at Christos Banquet Center at which David Parnell will be speaking about his battle with meth.

Senter said that on Friday, October 25<sup>th</sup> he will be hosting the Northern Indiana Mayor's Round Table at 11:00. He invited the council and department heads to the meeting at Christo's Banquet Center.

City Attorney Surrisi presented Resolution No. 2013-583, A Resolution Providing for the Transfer of Appropriations in the Aviation Rotary Department Fund of the City of Plymouth, Indiana, as Requested by the Board of Aviation Commissions and Forwarded to the Common Council for Their Action and Passage Pursuant to IC 6-1.1-18-6.

Councilmen Smith and Culp moved and seconded to adopt Resolution No. 2013-583. It passed by roll call vote.
