

REGULAR SESSION, COMMON COUNCIL, NOVEMBER 14, 2016

Be it Remembered that the Common Council of the City of Plymouth, Indiana, met in regular session on November 14, 2016. The meeting was held in the Council Chambers of the City Building, 124 N. Michigan Street, Plymouth, Indiana. The meeting was called to order at 6:35 p.m.

Mayor Senter led the Pledge of Allegiance and Council Member Delp offered prayer.
